

The notion of interest link covers the person's past or present interests or activities, of a patrimonial, professional or family nature, in relation to the object of the mission entrusted to him/her.

The interest can be:

- Material or moral :
 - Material or financial: remuneration or gratuity of any kind ;
 - Moral, consisting of a benefit in terms of recognition, occasional or regular, in all its forms, in particular for promotion or defence:
 - Personal interests that are not directly financial such as those related to professional responsibilities assumed or sought, or professional elected office held or desired,
 - The interests of groups, such as those of a professional school of thought, discipline or speciality - for example, in the exercise of responsibilities in bodies whose public positions on matters related to the requested mission could cast doubt on the independence, impartiality or objectivity of the person exercising them.
- Direct or through an intermediary :
 - Direct interest: an interest involving, in a personal capacity, directly for the person concerned, a benefit, i.e. remuneration, in money or in kind, or any form of recognition, occasional or regular, in any form whatsoever. Benefit is an advantage or an absence of disadvantage for oneself.
 - Indirect interest (or through an intermediary): interest involving, by reason of the mission carried out by the person concerned, a profit, remuneration or gratuity, or an absence of disadvantage, for the benefit of another person, natural or legal (institution, organisation of any kind), with whom the person concerned is in contact, or a disadvantage for that other person (which the person concerned might wish for), under conditions such that the conduct of the person concerned could be influenced, even if he receives no personal benefit.
- Old, even future:
 - The declaration of interests requires the declaration of current interests but also those that existed during the last five years ;
 - In the interests of fairness, and even if the declaration of interests does not provide for this, the persons concerned should inform about the links of interest which they know, at the time they make the declaration, that they will appear in the near future.
